- We assess potential risks related to slavery and human trafficking within our limited supplier network and rate, review our suppliers on an annual basis

#### Supplier and Contractor Compliance

We expect our critical suppliers and contractors to uphold our values against modern slavery. To this end, we:

- Request a commitment from our critical suppliers to collaborate with us in identifying and addressing any risks of slavery within our supply chain
- Track their responses annually to reinforce their compliance with our anti-slavery stance

#### Awareness and Training

• We aim to raise awareness of modern slavery risks within our business. We provide briefings to relevant staff and include anti-slavery practices as a topic for discussion in team meetings.

#### Key performance indicators

Our organisation is committed to tracking and improving our efforts to tackle modern slavery by
monitoring key performance indicators (KPIs) such as the number of employee and supplier training
sessions conducted, percentage of suppliers screened for modern slavery risks, number of reported
concerns or incidents investigated, and completion rate of our supplier audits each year. We will log
these KPIs annually to measure progress and continuously improve our practices. All records related
to these KPIs and our actions to address modern slavery will be kept on file as part of our compliance
documentation.
